- \cdot The detention area clean up is completed and invoicing for this has been paid to KRT Concrete in the amount of \$2,500..
- \cdot David K. will continue to monitor garbage cans left out on non trash days.
- · Worked through open PCHAO email pending approvals for fences, pools, and other homeowner needs.
- \cdot All files from Bill over his course of tenure have been turned over to Robert and he is going to work on scanning them all into E-Files so they are accessible to everyone.
- · Robert Abbink and DeAun Geiger were voted by the board of the Prairie Crossings HOA to be added to the PCHOA Bank account due to Bill's departure and retirement last month on May 6th.
- · Block Party August 9th from 4-7pm. Rental tents, chairs, and tables, as well as the face painting service has been booked.
- \cdot Open Arc Seat No inquiry from the neighbors in Prairie Crossings has presented interest in joining the board. We plan to bring this open position up in front of our neighbors that join during the August 9th block party.
- · The PCHOA attorney has placed liens on certain properties due to long-standing nonpayment of dues, despite multiple attempts to resolve the matter—including the offer of payment plans. These legal actions were taken only after consistent refusal to pay over several years.

Please note: Attorney fees associated with these liens are not the responsibility of the PCHOA community. These costs will be recovered if and when the affected homeowners attempt to sell or refinance their properties.

- · Pond Area Trash Cleanup Effort Trash accumulation around the pond has increased, largely due to windy conditions on trash pickup days and increased foot traffic in the area. In response, one of our neighbors has generously volunteered to lead a cleanup effort with their youth group before trash collection days. To support this initiative, a trash can will be provided—at no cost to the Board or the volunteer group. We appreciate their community spirit and willingness to help keep our shared spaces clean!
- \cdot We will be replacing the "No swimming, no fishing, no boating" sign that was knocked down in the pond.
